# Trump uses "emergency" status of pandemic to further roll back environmental protections

In early June, President Trump signed an executive order instructing agency heads (former oil lobbyist David Bernhardt of the Department of the Interior, former coal lobbyist Andrew Wheeler of the EPA, and Interim head of the Bureau of Land Management William Perry Pendley) to waive long-standing environmental laws in order to speed up the federal approval of new mines, highways, and oil and gas pipelines. Citing an economic "emergency" gives the President the authority to invoke a section of federal law which allows, "action with significant environmental impact" without observing the requirements of NEPA or the Clean Air & Water Act citing the two as "unnecessary

### **Good News**

On June 17, the Senate took its final vote on the Great American Outdoors Act and passed the bill 73 to 25. Spearheaded by Senators Cory Gardner and Steve Daines (both Republicans are up for reelection this year) the bill has broad bipartisan support, and would commit \$1.9 billion a year to conservation, recreation and park maintenance and provide full and permanent funding for the Land and Water Conservation Fund (LWCF). ## **Vote! Your voice counts!**

Make sure you are registered to vote! Colorado's PRIMARY ELECTION DAY is Tuesday June 30. There are important federal, state, and local races on the ballot. Congress (that includes members of the senate and the house of representatives) controls the budget of land management agencies. Public land management and stewardship is dependent on their support and funding. And the Administration (the President and the executive branch) has broad discretion over agency policies.

## These are the details you should know:

- Every Coloradan who is registered to vote at their current address will receive a ballot in the mail.
- If you are a registered Democrat or Republican, you will be mailed the ballot of the party you are registered with. If you are an unaffiliated voter, you will receive both a democratic and a republican ballot. You can ONLY vote and return one. If you mark and return both ballots, they will both be rejected and your vote will not count.
- You can return your ballot by mail OR drop it off at any drop box. To find a drop box near you, visit <a href="www.justvotecolorado.org">www.justvotecolorado.org</a>\*. To vote by mail you must mail your ballot by June 22nd. If by June 22nd you have NOT received your ballot you can visit a Voter Service and Polling Center (VSPC) in your county to receive a ballot. You can find a VSPC near you at <a href="justvotecolorado.org">justvotecolorado.org</a>
- You can make sure that you are registered to vote at your current address or register to vote for the first time by visiting <a href="www.GoVoteColorado.com">www.GoVoteColorado.com</a>. You can also register in person on the same day you vote at a Voter Service and Polling Center.
- Ballots must be received by 7PM on Tuesday, June 30th. Ballots postmarked on June 30th but received later will not count.

# **COWPL** in the Works

COWPL's name, mission and work are becoming better known in our community and throughout the state! We continue to educate and inform people about our rights on our public lands. We actively assist Colorado communities confounded by, or working on, proposed privately driven land exchanges. Here is an update on a current project we are engaged in:

**Buffalo Horn Proposed Land Exchange** - We received and analyzed the appraisals for the private and public lands in the proposed exchange. COWPL's analysis determined that the appraisals for the private and the federal lands have been treated differently and inconsistently, particularly the question of access. In addition, parcels C1 and F5 are undervalued. These are a few highlights from our report:

- The federal appraisal relies on a hypothetical condition that exempts federal lands from appropriate additional analysis, specifically, the before and after approach. Consideration of before and after conditions will show that the exchange adds value to both the acquired public parcels and to the existing Buffalo Horn parcels. The situation of C1 and F5 enhance their pre-exchange assemblage, recreation and agricultural value. Post-exchange, the proponent will benefit from and control access to C1 and F5.
- The appraisal instructions incorrectly create an aggregated "larger parcel". COWPL's analysis shows that the criteria for creating a "larger parcel" are not met in this case. The sizes and values of parcels C1 and F5 are considerably greater than the other parcels and merit separate appraisals.
- The appraisals over-emphasize the value of motorized access to properties in the exchange, inappropriately discounting the value of the federal lands and over-valuing the non-federal parcels. Several of the 16 selected comparable sales share similar access to C1 and F5 and support buyers' willingness to acquire these properties at market prices.
